



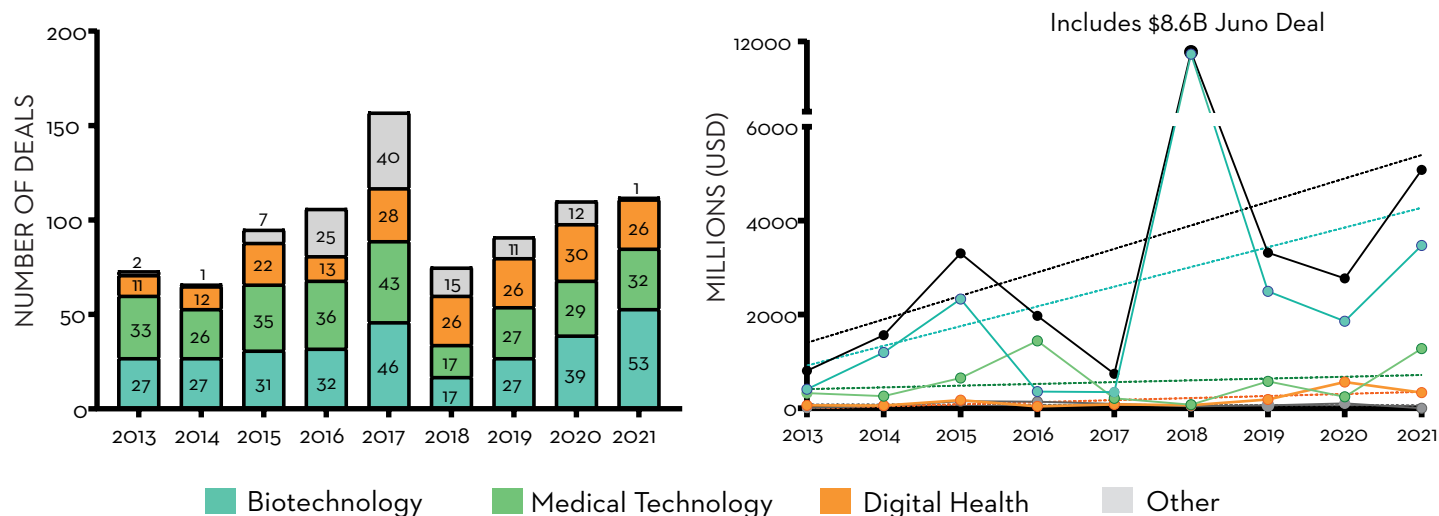

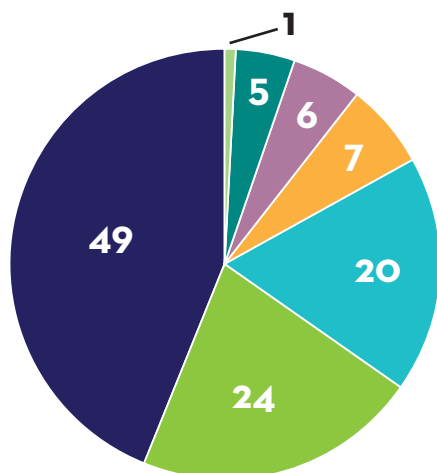

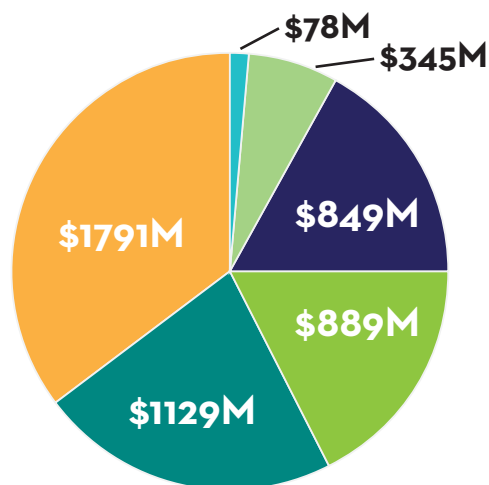
## FUNDING BY TYPE

# OF DEALS PER SECTOR

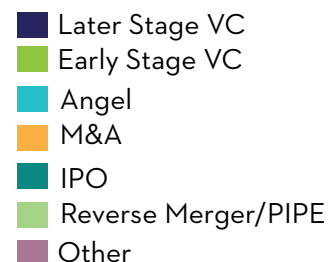
